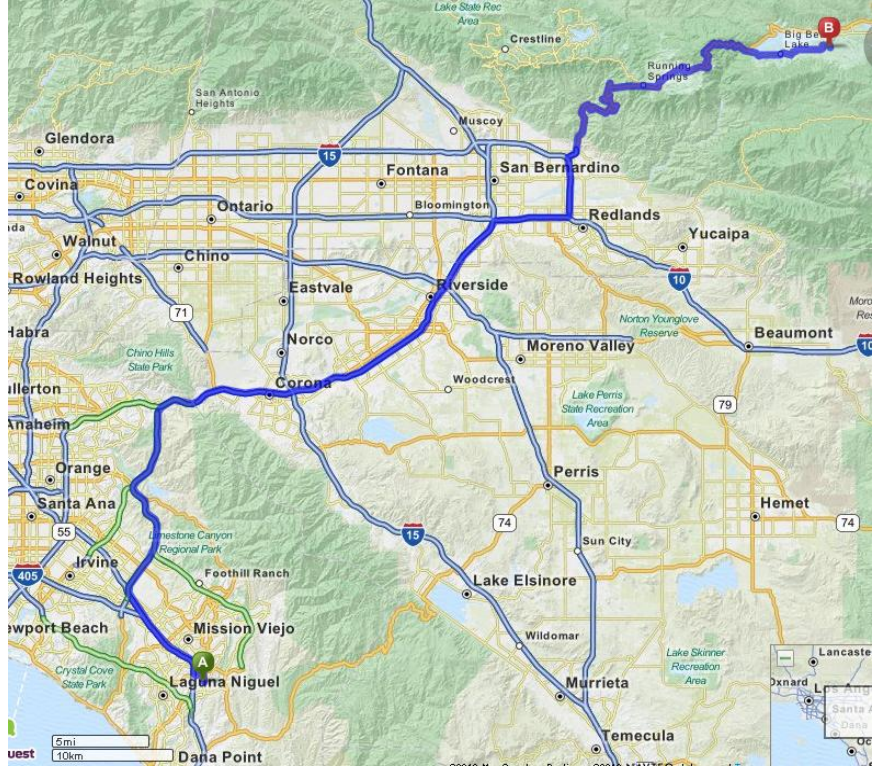

Directions from the Church of Christ at Mission Viejo

CA-241 N to CA-91 E: 2 hrs 14 mins / 100.15 miles

1. Start out going **north** on **Marguerite Pky** toward **Mesilla**. 0.8 mi
2. Turn **left** onto **Oso Pky**. 0.6 mi
*Oso Pky is 0.1 miles past Claro
If you reach Via Angelina you've gone about
0.1 miles too far*
3. Merge onto **I-5 N** toward **Los Angeles**. 7.7 mi
4. Merge onto **CA-133 N** via **EXIT 95** toward **Riverside** (Portions toll). 3.5 mi
5. Merge onto **CA-241 N** via **EXIT 14B** on the **left** toward **Riverside** (Portions toll). 9.4 mi
6. Take **CA-241 N** (Portions toll). 2.8 mi
7. Merge onto **CA-91 E** via **EXIT 39A** toward **Riverside**. 25.0 mi
8. **CA-91 E** becomes **I-215 N**. 5.5 mi
9. Merge onto **I-10 E** via **EXIT 40A** toward **Redlands**. 5.4 mi
10. Merge onto **CA-210 W** via **EXIT 77B** toward **CA-330/Highland**. 4.6 mi



11. Merge onto **CA-330 N** via **EXIT 81** toward **Mtn Resorts**. 15.5 mi
12. **CA-330 N** becomes **CA-18**. 16.4 mi
13. Turn **left** onto **Big Bear Blvd/CA-18**. 2.3 mi
*Big Bear Blvd is just past Modoc Dr
Village Pizza is on the corner
If you are on Village Dr and reach Bonanza Trl
you've gone a little too far*

14. Turn **right** onto **Fox Farm Rd**. 0.5 mi
*Fox Farm Rd is just past Catalina Rd
Get the Burger is on the corner
If you reach Interlaken Cir you've gone about
0.2 miles too far*
15. Take the 3rd **right** onto **Crater Lake Rd**. 0.2 mi
*Crater Lake Rd is just past Santa Clara Blvd
If you are on Fox Farm Rd and reach Crystal
Lake Rd you've gone a little too far*
16. **425 CRATER LAKE RD** is on the **left**.
*Your destination is just past Crystal Lake Rd
If you reach the end of Crater Lake Rd you've
gone a little too far*
